



## Two qualifications in one



Gain an MSc degree and your ACCA professional accountancy qualification at the same time. By taking the University of London master's route to ACCA membership you will be rewarded with two world-renowned qualifications. The University of London and ACCA (the Association of Chartered Certified Accountants). the global body for professional accountants, are enabling you to complete an MSc in Professional Accountancy and your ACCA professional accountancy qualification at the same time. This route to the ACCA qualification will be of value to accountants aspiring to senior roles and enable them to stand out from the crowd in terms of their qualifications.

Compared with the cost of studying for an accountancy qualification and an MSc separately, this will save time and money for many ACCA students, affiliates and members.

#### **Dual recognition**

With the creation of this MSc, ACCA will uniquely and for the first time recognise two MSc modules as counting towards the professional level of the ACCA Qualification. The University of London will recognise ACCA exams as counting towards the MSc.

You have flexibility in how you structure your studies and there are different pathways to the award depending on the stage you are at in your ACCA professional qualification journey. ACCA students who have passed the Fundamentals level exams can continue towards their ACCA Qualification by using the MSc as an equivalent to the two options exams (P4 and P5).

ACCA members and affiliates can complement their professional qualification with this MSc by completing one University of London module and a project only. The University of London recognises the learning that has taken place as part of the ACCA journey and applies this as credit towards the MSc.

# Why study for a University of London master's?

# Study for your MSc by online supported distance learning

## Fit studying around your schedule

You can set your own workload and complete the MSc in under a year, or take longer if that is more convenient, and depending on where you are on your ACCA journey. You can study from one to three modules at the same time.

Each module takes 22 weeks to complete and you will need to allow about 12-15 study hours per week, which includes time spent on coursework and revision. There are fixed times for submitting coursework. To help you meet these deadlines you are provided with a clear structure for your learning and online tools to plan and manage your time. Modules may run between one and four times a year.

## Comprehensive and interactive study resources

You study using materials developed for online learning, provided in a choice of formats for use with different types of computers, including mobile devices. Study materials include videos, readings, computer software, case studies and more. Interactive exercises and quizzes with automated feedback are embedded throughout.

There are links within the modules to the University of London online library and study resources. You do not need to purchase any additional textbooks.

## Network with professionals worldwide

The University's Virtual Learning Environment (VLE) enables you to network with other professionals in your tutor group worldwide. You will be able to share perspectives, compare approaches and gain a truly global viewpoint.

## Web supported learning

You can choose the web-supported study option which provides you with an online tutor and student relationship manager to support you in your studies. They will introduce the key content at the start of each module, guide you on the assessment, participate in online forums, and respond to your queries.

#### Getting started

As soon as you register you can start on the orientation module. This will help you get up to speed with the programme concepts and help you hone your study skills.





#### Local teaching support

As an alternative to the web-supported learning option – depending on where you live – you may be able to take face-to-face classes at local teaching centres for an additional fee. We are establishing a network of centres in the locations where students are planning to study. These centres have been recognised by the University of London for the quality and standards of their teaching. The list of centres will be on the Directory of Institutions on our website: apps.londoninternational. ac.uk/onlinesearch/institutions Classes may be held on a part-time or block basis.

#### **Assessment**

The master's is assessed through a combination of methods including coursework, projects and written paper examinations. The grade you achieve

for each module is based on all the elements of assessment. If your module includes an exam, you can take it in any of our exam centres worldwide. You can submit coursework and projects online through the University's VLE.

## Build up your qualifications

You may be able to start your studies with a Postgraduate Certificate if you have not passed all the ACCA P1-P3 exams. When you have successfully completed the Certificate and ACCA P1-P3 exams you can transfer to the MSc programme.

## Celebrate your graduation

Mark your achievement with your friends and family at the annual graduation ceremony in London, which is usually presided over by the University of London's Vice-Chancellor or Chancellor HRH Princess Royal.

## Join a global alumni network

On graduation you become a member of the University of London International Programmes Alumni Association. You may participate in our global events, meeting other graduates in your academic or professional field.

## How you study

Like the ACCA Qualification, the MSc in Professional Accountancy has been designed to support you in developing the high-level knowledge and intellectual skills needed for leadership of the finance function in a global context. This programme will help you develop the commercial, strategic and creative skills to address the challenges presented by today's fast-paced, volatile and interconnected world.

#### Pathway 1 – MSc for ACCA students who have passed P1-P3

Completed ACCA F1-F9 (or a recognised degree) plus ACCA P1-P3

Eligible to register for the MSc with 90 credits recognised prior learning (RPL)

Need to complete two University of London (UoL) option modules and the Project for the MSc

UoL module 1 30 credits

> UoL module 2 30 credits

UoL Project 30 credits

#### Pathway 1 - Postgraduate Certificate (PG Cert) with transfer to the MSc once P1-P3 successfully completed

Completed ACCA F1-F9 (or a recognised degree). Have not completed ACCA P1-P3 although may have started it

Are eligible to register for the PG Cert. Will need to complete 2 x UoL modules **and** P1-P3 to be eligible to transfer (with 90 credits RPL) to the MSc. Will then complete the Project for the MSc

#### Pathway 2 – MSc in Professional Accountancy for ACCA members and affiliates

An ACCA member or affiliate with a compliant CPD record with ACCA.

May be eligible to register for the MSc with 120 credits RPL. There is a limit of five years for recognition of prior learning. If you passed your last professional level paper over five years before the start of the MSc you will need to pass the online preparation test for the programme

Recognition of ACCA professional level, plus compliant CPD record, and if applicable, passed the online preparation test 120 credits

#### Strategic financial management (from January 2016)

This module will give you the tools to evaluate business financing options, manage financial risks, and make appropriate investment decisions. It takes a proactive and logical approach to decision making in areas such as investment appraisal; financial risk management; capital structures; dividend policy; mergers and acquisitions; and using financial instruments to manage risks.

**Assessment:** This module is assessed by coursework and an examination.

#### Strategic performance management (from January 2016)

This module develops the skills to design, implement and evaluate an organisation's performance management system. The emphasis is on making well-informed decisions, gaining insights into the blend of financial analysis and managerial judgment required to enable managers to make sound decisions. It provides the essential toolkit that managers need when faced with making hard-edged decisions to improve performance in the context of a complex and everchanging business environment.

**Assessment:** This module is assessed by coursework and an examination.

#### Strategic financial project (from July 2016)


This is a mandatory capstone module which presents an opportunity to challenge yourself to demonstrate independent academic research skills and apply them in a professional context. You will present an analysis of, and potential solutions and recommendations to an accounting/finance related business issue. As a result of this process you will develop a critical self-awareness which will increase your personal effectiveness in a business context.

Assessment: This module is assessed by coursework and a project.

#### Global Issues for the finance professional (from July 2016 as part of Pathway 2, only for members and affiliates)

This provides insights into how finance and accounting is evolving in today's unpredictable global environment. It will give you the skills to think critically and creatively in selecting alternative solutions and solving complex problems. The module addresses topical issues such as the valuation of intangibles; the impact of the Basle Accord on financial risk management practices; global mergers and acquisitions; convergence and divergence of international harmonisation of taxation, financial reporting and accounting standards; social and environmental accounting and reporting. **Assessment:** This module is assessed by coursework and a project.

# Entrance requirements and how to apply



## Entrance requirements

Only those registered with ACCA are eligible to study towards the MSc in Professional Accountancy.

#### Qualifications required under Pathway 1:

Passed all the ACCA F1 to F9 exams, and passed the ACCA P1, P2 and P3 exams.

#### Qualifications required under Pathway 2:

If you passed the last of the ACCA Professional level exams more than five years ago, you must be able to demonstrate that your Continuing Professional Development (CPD) record is compliant with the ACCA policy on CPD since you became a member. This includes an up-to-date CPD declaration for the current year. Additionally, you will be required to successfully pass the assessment for the University of London Professional Accountancy Online Preparation Test which will be available on demand.

#### Qualifications required for the Postgraduate Certificate in Professional Accountancy:

Passed all the ACCA F1 to F9 exams or their equivalent.

You can apply online at: londoninternational.ac.uk/msc-accountancy

After you have completed the application process you will receive feedback on your eligibility. If you are successful you will be able to register and pay for the first modules you wish to take.

## How much will it cost?

Please see the website for the fee schedule. The fees vary depending on which country you live in, and whether you choose web-supported learning or classes at a local teaching institution.

You will pay for each module as you take it. The module fee includes access to study materials and entry into the assessments (written examination, coursework and project as applicable associated with the module, but excludes the fee charged by the local exam centre which you must pay directly).

You will also need to pay your ACCA subscription fees as normal to continue to be eligible to study towards and be awarded the MSc.
